The dam was removed in Oct 2007, thus the count is included in the spawning ground survey estimate area and not added in. Starting in 2010 unmarked fish were released above the Sandy Hatchery weir. This area is not sampled, so these fish are added into the total abundance.

b = Spawning ground estimate does not include area above listed counting stations. *Note:* Sandy estimate is below Marmot Dam only from 2002-2006, and whole basin from 2007 on.
